In addition to his trial experience, Jim is a certified North Carolina Superior Court mediator, and a member of the federal court mediator panels for the Eastern, Middle, and Western Districts of North Carolina. His mediation practice is enhanced by his four decades of litigation experience in complex employment, commercial, and tort cases, and by his experience representing clients in hundreds of arbitrations and mediations.

His experience includes Title VII and ADEA employment discrimination cases, sexual harassment and wrongful termination cases, and class actions. He has extensive experience in the litigation of breach of contract and product liability cases, as well as motor vehicle negligence cases, including wrongful death claims, and coverage issues arising from life insurance and disability insurance policies. He has substantial experience in the litigation of environmental and land use disputes. Jim and his partners won a landmark decision from the Florida Supreme Court, after ten years of litigation, preserving Florida's ownership of sovereignty lands – lands beneath navigable rivers and lakes -- from claims to the private ownership of these river and lake beds and the mineral deposits beneath them.

In addition to his trial and appellate experience in state and federal courts, Jim has frequently appeared as lead counsel in arbitration matters involving securities and employment law disputes before the Financial Industry Regulatory Authority (FINRA), the AAA, and other leading arbitration forums.

He has substantial experience in the litigation of issues related to the preservation of electronic evidence, and punitive damages. He served as lead trial counsel in *Zubulake v. UBS*, which resulted in a \$29,273,190 jury verdict, including \$20,000,000 in punitive damages, in the Southern District of New York for an institutional securities saleswoman on claims for gender discrimination and retaliation under state and federal law. The verdict in *Zubulake* also is widely noted for its seminal decisions setting forth the electronic evidence preservation obligations of litigants in federal cases.
